I urge you to reject Invenergy's Proposed Power Plant in Burrillville. A new power plant fueled by burning methane gas and diesel is not a solution for Rhode Island. We know the impacts of gas plants on surrounding communities (asthma and reduction in public health), we know the current proposal will threaten the remaining natural forests of the state, and we know the impacts it will have on our drinking water supply (water pollution, water usage will exponentially affect our drinking water supply). This may not be much of a concern for you, but we know that most of the fracked gas that will fuel the proposed powerplant will eventually make all drinkable water sources in Pennsylvania hazardous to consume (fracking contaminates reservoirs and underground aquafers). The plant has not even been built and fresh drinking water in RI and Southern Massachusetts is already at risk and under threat (PWSB, Narragansett, Fall River).

In order to mitigate climate change impacts, we must invest in creating healthier and more resilient communities, instead of investing in the extractive industries that contribute to climate change without regard to the public's health.
