
This report of The Narragansett Electric Company d/b/a National Grid (“National Grid” or the “Company”) is filed with the EFSB in response to its request at the hearing on October 22, 2014 that the parties resume filing quarterly reports on the status of the E-183 Underground Relocation Project commencing on January 15, 2015.

Since its January 15, 2016 Report, National Grid has had further discussions on route alignment alternatives and risks. National Grid has also provided comments to the Senate Commerce Committee on S-2164, which would amend the Siting Act and change the terms of the Settlement Agreement among the parties.
