1. INTRODUCTION

Pursuant to section 1.10 of the Energy Facility Siting Board(EFSB) Rules of Practice and Procedure, the undersigned residents who live in the immediate vicinity of the above referenced matter file this motion for late intervention. 2. ARGUMENT
