

MOTION FOR INTERVENTION  
RESIDENTS OF WALLUM LAKE ROAD, PASCOAG, RI

**I. INTRODUCTION**

Pursuant to Section 1.10 of the Energy Facility Siting Board ("EFSB") Rules of Practice and Procedure, the underside residents who live in the immediate vicinity of the above referenced matter file this Motion for Intervention. The residents' intervention in the above captioned matter is appropriate and in the public interest. Accordingly, this Motion for Intervention should be granted.

**II. ARGUMENT**

Section 1.10(b) of the EFSB Rules of Practice and Procedure provides that "any person claiming a right to intervene or an interest of such nature that intervention is necessary or appropriate may intervene in any proceeding before the Board." The residents who on Wallum Lake Road in the immediate vicinity of the proposed "Invenergy Clear River Energy Center-Project" ("CREC") will be directly affected by this project and are not adequately represented by existing parties and may be bound by the Board's action in the proceeding.

CREC will consist of a combined-cycle electric generating facility to be located at the Spectra Energy Algonquin Compressor Station site, on Wallum Lake Road (State Route 100) in Pascoag, RI. The project site is located in a forested predominantly rural area. The closest residents live approximately 0.10 miles from the north-Northeast corner of the property. The residents have a genuine interest in preserving their property and are concerned about the adverse economic impact the CREC project will have on property their values. Other resident concerns about the CREC project include: the negative impact of traffic, both during construction and during site operation; the negative environmental impact, including on the land and wildlife resources; the health and safety of the residents; the purity of the air and water, and the aesthetic and recreational values of the community. The CREC project will have a negative impact on the rural character of the area and on future development. The residents in the immediate vicinity of the CREC will be deprived of the full use and enjoyment of their property should this project go forward.

III. CONCLUSION

Based on the reasons stated herein, the undersigned residents of Wallum Lake Road in the immediate vicinity of the CREC project respectfully request that the EFSB grant this Motion for Intervention.
