Proposed Major Energy Facility

Wallum Lake Rd (Route 100), Burrillville

Dear Mr. Bianco,

We received your letter dated November 5, 2015 and a copy of the RI Energy Facility Siting Board application for a proposed major energy facility in Burrillville. The proposed facility would be off Wallum Lake Road (Route 100), a State maintained roadway.

For any alterations to the State Highway system, Invenergy Thermal Development LLC ("Invenergy") must submit a Physical Alteration Permit Application (PAPA) to the RI Department of Transportation ("RIDOT") for review and approval. Alterations include the proposed new driveway access to Route 100 and any alterations that affect the drainage within the State Highway Right-of-Way ("ROW"). There should be no net increase of stormwater runoff entering the State's drainage system. Since the proposed facility will store fuel on site, all newly generated stormwater runoff should be contained on site, and not directed to the State Highway ROW.

Invenergy must also submit a Utility Permit Application to the RIDOT for review and approval for the proposed sewer and water lines along Route 100. The roadway will have to be resurfaced as part of the restoration work.



As you may be aware, Invenergy Thermal Development LLC ("Invenergy") has filed an application to construct a major energy facility within the Town of Burrillville with the Rhode Island Energy Facility Siting Board ("Board") pursuant to R.I. Gen. Laws § 42-98 Energy Facility Siting Act. Rule 1.5(f) of the Board's Rules of Practice and Procedure requires the Coordinator to transmit the application to any person designated by the Board within five business days after the filing.

As Invenergy indicated in its application that the Department of Transportation has licensing or permitting authority over the project, which may be superseded by the Board's jurisdiction, I am transmitting a single hardcopy of the application to your office.
