In compliance with Report and Order No. 15382 and Notice of Errata Order No. 15399 in the above-referenced docket, enclosed please find four copies of National Grid's¹ quarterly Open Access Customer Data Report for the first quarter of 2018.

National Grid respectfully requests confidential treatment of the supplier names and pricing information contained in the attached report. This information is commercially sensitive and proprietary, and the disclosure of this information could negatively affect the balance of the wholesale markets as well as National Grid's ability to negotiate competitive terms with its wholesale electricity suppliers. Therefore, National Grid requests that this letter serve as the Company's request for confidential treatment pursuant to Rule 1.2(g) of the Public Utilities Commission's (PUC) Rules of Practice and Procedure, and that the PUC afford confidential treatment to the enclosed report. National Grid respectfully requests that, pending entry of that finding, the PUC preliminarily grant the Company's request for confidential treatment pursuant to Rule 1.2(g)(2).

In compliance with Rule 1.2(g)(3), and per the PUC's request, I have enclosed three unredacted copies of the confidential document in a sealed envelope marked, "**Contains Confidential and Privileged Materials - Do Not Release.**" I have also enclosed a PDF file of the non-confidential data for the electronic filing to facilitate posting of the data on the PUC's website.
