National Grid respectfully requests confidential treatment of the supplier names and pricing information contained in the attached report. This information is commercially sensitive and proprietary, and the disclosure of this information could negatively affect the balance of the wholesale markets as well as National Grid's ability to negotiate competitive terms with its wholesale electricity suppliers. Therefore, the Company requests that this letter serve as the Company's request for confidential treatment pursuant to the Rhode Island Public Utilities Commission's (PUC) Rule 1.2(g), and that the PUC afford confidential treatment the enclosed report. National Grid respectfully requests that, pending entry of that finding, the PUC preliminarily grant National Grid's request for confidential treatment pursuant to Rule 1.2(g)(2).
