RE: Docket 3739 - The Narragansett Electric Company Standard Offer Filing

Dear Ms. Massaro:

The Narragansett Electric Company, d/b/a National Grid (the "Company") has reviewed the memorandum submitted by the Division to the Commission today and wishes to provide the following comments.

The Company understands that the question regarding whether to lower the standard offer rate at this time is a difficult one. The Division has provided a rational basis for doing so. In particular, it is reasonable to consider lowering the rate in two steps, rather than one. This is especially important in light of the coming hurricane season and predictions of further storms.

Notwithstanding the Division's reasoning, however, the Company would prefer to wait until September 1 to make any changes to the standard offer rate. The Commission's trigger of \$23 million for a rate change has still not been met. The projected over-recovery through the end of June, using the latest index figures, is \$14.1 million. The projections still show the reconciliation balance below the trigger as of the end of August. As the Company stated in its last standard offer reconciliation report, the fuel markets remain volatile. Thus, the Company recommends retaining rate stability and lowering the rate when the numbers approach the Commission's trigger with more certainty.

Having stated this, however, the Company has no strong objection to the Division's proposal. This issue is very much a policy determination by the Commission and the Company is prepared to act in accordance with the Commission's direction on this question.
