NOTICE OF RULEMAKING AND PUBLIC HEARING

Pursuant to the provisions of Rhode Island General Laws §§39-1 and 42-35 of the Rhode

Island General Laws, as amended, the Public Utilities Commission ("Commission") hereby gives

notice that it will conduct a hearing on Monday, November 27, 2006 at 9:30 A.M. in the first-

floor hearing room of the Public Utilities Commission at 89 Jefferson Boulevard, Warwick,

Rhode Island for the purpose of affording all interested persons an opportunity to submit data,

views, or arguments, orally or in writing, in response to the Commission's plan to amend the

current Rules and Regulations Governing the Termination of Residential Electric, Gas and Water

Utility Service adopted by the Commission on May 1, 2002.

The purpose of the amended regulations is to establish a summer moratorium on utility

service shutoff on days when the National Weather Service issues an excessive heat advisory or

excessive heat warning for Rhode Island. The regulations will apply to all residential customers

of regulated electric, gas and water utility service.

The rules and regulations, in both form existing and proposed in a redacted version

specifying additions are on file at the Clerk's office and may be examined there. Copies of the

proposed regulations may be obtained in person at the Commission's office, by mail by calling

941-4500, ext. 107, or may be accessed at www.ripuc.org/eventsactions/docket.html.

Interested parties and members of the public wishing to offer data, views or arguments

regarding the amended regulations may do so either orally on the day of the hearing or in writing

prior to the hearing date. In addition, written comments will be accepted at the above address

until 4:00 P.M. on November 30, 2006. An original and nine (9) copies of written comments must be filed with the Clerk.

Reference is also made to Chapters 42-35 and 39-1 of the Rhode Island General Laws. Specifically Sections, 42-35-1, 42-35-2, 43-35-3, 42-35-4, 42-35-5, 39-1-1, 39-1-3, 39-1-11, 39-1-18 and 39-1-38.
