Motion for Relief from Order

Dear Ms. Massaro:

This letter serves as a Motion for Relief from Commission Order No. 18973 (May 31, 2007) in accordance with Rule 1.28(b) of the Commission's Rules of Practice and Procedure. In Order No. 18973, the Commission approved National Grid's Affordable Energy Plan, which included the introduction of a discounted distribution rate for low-income gas customers, and required the Company to file a tariff revision consistent with the order. As described in the order and R.I.G.L. § 39-1-27.10, National Grid's discounted gas rate was to be funded through the affordable energy fund created by statute and implemented via the strategic plan of the Office of Energy Resources ("OER").

In a letter filed with the Commission on July 12, 2007, Mr. Dzykewicz, Commissioner of OER, explained that with the passage of the FY 2008 budget, the Rhode Island General Assembly eliminated funding for the affordable energy fund. Accordingly, such budget changes effectively made the OER strategic plan submitted to the Commission "null and void."

Since the foundation of the Company's plan relied on an appropriation from OER, and since there is no funding to implement the discounted distribution rate for low-income gas customers, the Company respectfully withdraws the low-income discounted gas rate from its Affordable Energy Plan and requests that it need not file any tariff revision.
