

Quarterly Customers:

Bills Mailed:	On or about January 10 <sup>th</sup>
Bills Due:	March 1 <sup>st</sup>
Penalty Charge Applied:	March 2 <sup>nd</sup>
Interest Applied:	April 2 <sup>nd</sup>

The quarterly billing pattern repeats for bills mailed in:

July  
October
