Dear Ms. Massaro:

On March 27, 2007, National Grid<sup>1</sup> submitted a tariff advice filing to Amend its GreenUp Service Terms and Conditions R.I.P.U.C. No. 1167-B, to become effective November 12, 2007. The Commission approved the Company's tariff advice filing in Order No. 18956 (May 11, 2007).

I am writing with regard to the implementation date of the revised Terms and Conditions for GreenUp Service. National Grid had requested approval to implement the revised Terms and Conditions on November 12, 2007, coincident with planned changes to its Customer Service System. At this time, it appears that the software changes necessary to support the revised Terms and Conditions will not be complete until January of 2008. Thus, the Company intends to keep the current Terms and Conditions in place until it is able to implement the revised ones, at which time it will inform the Commission and file a revised tariff advice letter. National Grid has also notified GreenUp suppliers of this change in implementation date.
