

The packages offer a network access line, unlimited local and toll calling, and a choice of other features and services for a discounted, flat monthly rate. The packages will be offered with one-year or three-year term commitments to business customers who subscribe to 25 or fewer voice grade lines.

Verizon certifies that the rates for the Unlimited Dial Tone Line Package for Business and Unlimited CustoPAK Package for Business are not less than the Long-run Incremental Cost of providing the services.

Service Description

Verizon Unlimited Dial Tone Line (DTL) Package and Unlimited CustoPAK Package for Business offer customers the ability to combine their voice, calling features and Verizon Broadband Internet for a discounted flat monthly fee. The package is made up of one Main Expansion Pak Line and at least one Additional Expansion PAK Line plus Verizon's high-speed Internet Service. Customers have the option of a 1 or 3-year term agreement. The packages are available to business customers with 25 or less voice-grade lines, and they will be marketed as Verizon Freedom for Business Expansion PAK.

The Unlimited DTL and Unlimited CustoPAK Packages for Business provide business customers with the convenience of combining their dialtone or CustoPAK line, additional features, unlimited calling, and internet access into one monthly rate. These packages position Verizon to provide value to business customers and compete effectively with similar offers by its competitors.

Package Contents:

The Unlimited Dial Tone Line Package for Business and Unlimited CustoPAK Package for Business include:

- A Main Expansion Pak Line under a 1 or 3-year term
 - Dial Tone or CustoPAK Line
 - Choice of Calling Features
 - Choice of Voice Mail
 - Unlimited nationwide calling
- At least one Additional Expansion PAK Line sold on a month-to-month basis
 - Additional Expansion PAK Line with Unlimited calling
 - Choice of Calling Features
 - Choice of Voice Mail
 - Unlimited nationwide calling
 - Additional Expansion PAK Line without unlimited calling
 - Choice of Calling Features
 - Choice of Voice Mail
- Verizon Broadband Internet

Unlimited nationwide calling may be placed on only 10 lines per account. This includes the Main and Additional Expansion PAK Lines plus any other Verizon Freedom for Business plans on the account. In order to maintain the rate associated with the package, the customer must keep one Main Expansion PAK Line and one Additional Expansion PAK Line on their account.

Call detail is not provided with this service.

The Main Expansion PAK Line and all Additional Expansion PAK lines include five features: Call Waiting, 3-Way Calling, Caller ID, Call Forwarding, and Voice Mail. Customers can choose one to five of the features. Additional features may be added at tariff rates.

Verizon must be selected as the regional toll and long distance carrier on all lines in the package.

Rates and Charges

Non-recurring charges do not apply to establish the packages when ordered under a three-year term.

Once Verizon Broadband Internet Service is provisioned with the package, a \$1.00 or \$5.00 discount applies, depending on the term of the package.

Verizon certifies that the rates for the Unlimited Dial Tone Line Package for Business and Unlimited CustoPAK Package for Business are not less than the Long-run Incremental Cost of providing the services.

Term Commitment, Termination Liability Charges and Autorenewal

The Unlimited Dial Tone Line Package for Business and Unlimited CustoPAK Package for Business offer a term option in exchange for discounted monthly recurring charges (MRCs). The Expansion PAK Main line will be offered on 1 and 3-year terms. Additional Expansion PAK lines will be offered on a month-to-month basis. The customer can add and delete the Additional lines without termination charges as long as two lines (the Main and one Additional line) remain on the account.

An early termination charge will apply if the customer disconnects the Main Expansion PAK Line prior to the expiration of the term commitment.

The early termination fee for the Main Expansion PAK Line is:

- 1-year term: \$75
- 3-year term:
 - \$225 if disconnected within the first year,
 - \$150 if disconnected between the first and the second year of the term, or
 - \$75 if disconnected between the second and the third year of the term.

The early termination charge for the Main Expansion PAK Line will not be charged if the line is disconnected prior to 60 calendar days of service of the order completion date.

The package will automatically renew for an additional 1 or 3-year term unless either party provides notice within 60 days of the renewal date that it does not wish to extend the package for a new term. Verizon will provide an advanced notification of the renewal date. At that time the customer may choose to leave the service as is, in which case the service will be renewed for an additional 1 or 3-year term. If the customer wants to cancel the package or switch to a different term agreement, they may contact the local business office to make that change. Written cancellation of the plan is not required.

Early termination of Unlimited DTL Basic Package or Unlimited CustoPAK Basic Package term agreement by the customer will result in a one-time flat Termination Charge of: <u>1-year term agreement</u> \$75 <u>3-year term agreement</u> \$225 for default within the 1st year of the term \$150 for default within the 2nd year of the term \$75 for default within the 3rd year of the term
C.	If the customer cancels any of the unregulated components or all of the Expansion Line(s) of the bundle, the remaining components will revert to the individual rate and/or the tariff rate associated with that component.
D.	Customer termination of service within the first 60 days, starting on the Order Completion Date, will result in customer liability for the monthly charges. Termination liability will be waived.
E.	At the end of the Term or any subsequent renewal, the agreement will automatically be renewed for a successive one-year or three-year Term under the same terms and conditions, unless either party provides advance notice that it does not wish to renew the term. Each subsequent renewal will allow for a 60-day grace period for the subscriber to unsubscribe from the plan without penalty. Pricing will remain the same during any automatic renewal unless the Telephone Company has provided 30 days notice of any change. Customers can move from a one to a three-year term without incurring a penalty.
