
1. Bundle Discount

The unlimited long distance calling plan that is a qualifier for the Bundle Discount and the FiOS Bundle discount will include long distance calling to Canada. Therefore, the term “domestic” is no longer applicable and should be deleted from the tariff.

15.13.2 Application of Rates and Charges

Bundle Discount – A customer is eligible to receive a monthly discount on Regional Essentials when the customer also subscribes to an unlimited long distance calling plan, plus one of the following products:</p> <ul style="list-style-type: none"> - Verizon On-line Broadband (Up to 3M package). The discount provided will expire 12 months from the date it is implemented on a customer's account. At the end of the 12 months, regular rates apply. Customers are limited to one discount only and cannot combine discounts. Each product must be purchased through or billed by Verizon RI.</p> <p>2. Qualifying unlimited long distance calling plans must be consistent with Plan O Service – Unlimited as found in the Bell Atlantic Communications, Inc. FiOS Bundle Discount – A customer is eligible to receive a monthly discount on Regional Essentials when the customer also subscribes to an unlimited long distance calling plan, plus one of the following FiOS products with a 12 or 24 month commitment:</p> <ul style="list-style-type: none"> - FiOS Internet (packages of less than 50M download speed) - FiOS TV Premier - FiOS Internet (packages of less than 50M download speed) and FiOS TV Premier <p>1. Depending on the length of the commitment, the applicable FiOS bundle discount will expire 12 or 24 months from the date it is implemented on a customer's account. Discontinuance of any one of the services listed above will result in immediate termination of the discount. Each product must be purchased through or billed by Verizon RI.</p> <p>2.
