With this filing, Verizon Rhode Island (“Verizon RI”) proposes a rate increase to the following Enhanced FlexGrow® option:



The Analog Line/PBX Trunk/Centrex Plus option provides voice connectivity on a per channel basis for any channels the customer selects for an analog, PBX or Centrex voice line application.
