## Commission Data Request 1-1

#### Request:

Referencing page 3 of the Division's Motion for Clarification, please state when the Company's actual plant in service for the rate year, the twelve months ending September 30, 2009 will be available.

- a. When will the Company file that number with the Commission? Please provide a timeline if the Company is anticipating multiple filings.
- b. When can the Company commit to filing the September 30, 2009 actual capital spending?
- c. In the event the actual numbers are not available for September 30, 2009 at the time of the Commission's hearing on the Distribution Adjustment Charge, what would the Company propose as a solution?

## Response:

- a– b The Company will include with its August 1<sup>st</sup> DAC filing 4 quarters of actual and one quarter of estimated data for the period ending September 30, 2009. The Company will update this data as part of its September 1<sup>st</sup> DAC filing to include one additional month of actual data and any updates to the remaining two estimated months. Subsequently, on or about September 15<sup>th</sup>, the Company will file actual data for August with any further updates to the estimate for September. Finally, on or about October 15<sup>th</sup>, the Company will file the final un-audited data for September. The Company's books will not be considered final until National Grid plc announces its earnings in mid-November. It is not anticipated that the Company's plant in service data that it will provide by October 15 will change.
- c. In the event that the actual numbers for the end of September 30, 2009 are not available at the time of the Commission's hearing on the DAC, the Company would propose using the latest available estimate subject to a true up in the subsequent year's DAC. With 14 months of actual data available in calculating the 5-quarter average, the Company would expect that any impact in the use of a forecast for September would be minor.
