**ORDER APPROVING COMPLIANCE FILING**

At a hearing held on December 1, 2008, the Public Utilities Commission (the “Commission”) considered National Grid’s November 26, 2008 Compliance Filing in this Docket. The Compliance Filing is based on the Commission’s rulings on the Company’s base rate filing at the November 24, 2008 Open Meeting, and includes:

- a. Attachment NG-Compliance MDL-1, Revenue Requirement Calculation
- b. Attachment NG-Compliance RD-1, Revenue Requirement Allocation
- c. Attachment NG-Compliance RD-2, Rate Design
- d. Attachment NG-Compliance RD-3, Bill Impacts
- e. Attachment NG-Compliance RD-4, Cost of Service Summary
- f. Attachment NG-Compliance PCC-1, Marked Tariff
- g. Attachment NG-Compliance PCC-2, Clean Tariff.

The Company identified on the record certain corrections and modifications to Section 5, Schedule G and Section 6, Schedule A of its proposed tariff (relating to non-firm sales service and non-firm transportation service), to which there were no objections.

The Company’s rebuttal testimony in this docket claimed a rate year revenue deficiency of \$18,455,000. In its deliberations, the Commission determined the actual rate year revenue deficiency to be \$13,660,000. A rate increase of \$13,660,000 was approved by the Commission.

The Compliance Filing presented by the Company calculates new rates based upon the Commission approved increase.

The Division submitted a statement at the hearing agreeing that the Company's Compliance Filing calculated new rates accurately based upon the Commission approved increase of \$13,660,000.

After consideration of the Compliance Filing, the corrections and modifications submitted by the Company, and the Division's statement, and there being no objection to the Compliance Filing by any party or intervenor, it is hereby




That the Company's Compliance Filing, as corrected and modified at the December 1, 2008 hearing, is approved.


