

The George Wiley Center, by its attorney, moves under Rule 1.13 of the Rules of Practice and Procedure of the Public Utilities Commission to intervene as a full party in this action on the following grounds:


1. The George Wiley Center is a state-wide non-profit organization with headquarters in Pawtucket, Rhode Island.
2. The George Wiley Center's mission is to conduct community organizing and advocacy on behalf of all low-income Rhode Islanders.
3. The George Wiley Center has a long history of advocacy on behalf of low-income Rhode Islanders before the Public Utilities Commission.
4. The interests of the George Wiley Center are such that intervention is necessary and appropriate under PUC Rule 1.13(b). In particular, under PUC Rule 1.13(b)(2) and (3):
  - The interests of the low-income Rhode Islanders represented by the George Wiley Center will be affected by the requested rate increase.
  - Because a rate increase will have a disproportionately onerous impact on low-income Rhode Islanders, this group of customers is not adequately

represented by existing parties, who represent either broader, different or adverse interests before this Commission.

- Wiley Center clientele will be uniquely affected by the proposed discount for low-income customers.

WHEREFORE, the George Wiley Center asks that its motion to intervene be granted.


