The hearings may continue thereafter from day to day and time to time as required.

At this hearing, the Commission will examine the propriety of National Grid's ("Company") filing seeking approval to implement an increase to the Standard Offer Service Rate from 9.2¢ per kWh to 11.5¢ per kWh effective for consumption July 1, 2008. As proposed, the effect of the Company's filing on a typical residential customer using 500 kWh per month would be a bill increase of \$11.98 per month from \$76.77 to \$88.75, or approximately 15.6%. The Company

also presents an alternative calculation of a Standard Offer rate of 13.1¢ per kWh. Thus approval of Standard Offer rate could be in the range between 11.5¢ per kWh to 13.1¢ per kWh. The Company's filing represents that the cost for generation service under its Standard Offer Service contracts has increased as a result of increases in the price of oil and natural gas.

The Commission can approve different rates that may be higher or lower than those proposed by National Grid. The deadline to file a Motion to Intervene as a party in these dockets is June 13, 2008. The filings may be examined at the Commission's office and at the office of the National Grid, 280 Melrose Street, Providence, Rhode Island. The filings can also be accessed on the Commission's Docket Menu at www.ripuc.org,
