The hearings may continue thereafter from day to day and time to time as required.

In Docket No. 3961, the Company seeks approval to implement an increase to the Gas Cost Recovery ("GCR") factors effective for consumption July 1, 2008. The Company proposes to increase: 1) the GCR factors for all customer classes, 2) the Natural Gas Vehicle rate, and 3) charges associated with transportation services billed to Gas Marketers. The GCR would allow the Company to reconcile and collect sufficient revenues to recover projected gas costs for the sixteen

(16) month period July 1, 2008 through October 31, 2009. The proposed GCR factors on a per therm cost basis are: \$1.2429 for Residential and Small C&I customers; \$1.2352 for Medium C&I customers; \$1.2529 for Large Low Load Factor C&I customers; \$1.1985 for Large High Load Factor customers; \$1.2460 for Extra Large Low Load Factor customers; and \$1.1751 for Extra Large High Load Factor customers. The proposed commodity charge for Natural Gas Vehicles is \$0.9655 per therm. The bill impact of the GCR increase on a typical residential heating customer using 1,021 therms over the sixteen month period would be an increase of about \$10 per month from \$1,619 to \$1,780 or approximately 10%.

The Commission can approve different rates that may be higher or lower than those proposed by National Grid. The deadline to file a Motion to Intervene as a party in these dockets is June 11, 2008. The filings may be examined at the Commission's office and at the office of the National Grid, 280 Melrose Street, Providence, Rhode Island.
