NOTICE OF PUBLIC HEARING

Pursuant to the provisions of the Rhode Island General Laws §39-1-1 et seq, as amended, the

Public Utilities Commission ("Commission") will conduct a public hearing on Monday, September

22, 2008 @ 2:00 P.M. in Hearing Room A of the Public Utilities Commission, located at 89

Jefferson Boulevard, Warwick, Rhode Island. The hearing may continue thereafter from day to day

and time to time as required.

This docket relates to the Commission's review of Narragansett Electric d/b/a National

Grid's ("NGrid") request for the Commission to consider a Settlement Agreement executed between

NGrid, Constellation Energy Commodities Group ("Constellation"), and the Rhode Island Division

of Public Utilities and Carriers ("Division"). The proposed settlement relates to two Wholesale

Standard Offer Sales Agreements ("WSOSAs") the Company has with Constellation and two

additional Power Supply Agreements ("PSAs") the Company has with Constellation. The proposed

Settlement Agreement provides a resolution in two related civil actions that are pending in federal

court in Rhode Island and Massachusetts, and an appeal pending before the United States Court of

Appeals for the First Circuit regarding disputes over certain provisions of the WSOSAs and PSAs.

Under the terms of the Settlement, NGrid will make a lump sum payment of \$20,000,000 to

Constellation within ten (10) days of the Effective Date of the Settlement and then NGrid and

Constellation will amend the pricing and payment provisions of the two WSOSAs by adding a

monthly contract reservation charge applicable in 2009 of: (i) \$905,820.00 per month to one

WSOSA and (ii) \$1,610,344.00 per month to a second WSOSA commencing January 30, 2009 and

ending December 31, 2009. The Settlement and related amendments to the WSOSAs are conditioned on an approval by the Commission that permits NGrid to recover the costs of the Settlement in rates. If approved, assuming the recovery period is usage on January 1, 2009 through December 31, 2009, the effect of the Settlement on a typical residential customer using 500 kWh per month would be an increase of \$3.95 per month or 4.2 percent.
