1-1. Does the Navy purchase water from the Portsmouth Water and Fire District (PWFD)?

Response: Yes, the Naval Station Newport purchases potable water from Portsmouth Water & Fire District.

1-3. Does the Navy plan to continue purchasing water to the PWFD in the future? If the answer is in the affirmative, please provide an estimate of the amount of water the Navy plans to purchase from PWFD in the next five fiscal years beginning with FY 10.

Response: Naval Station Newport has awarded the construction contract for the repair project of the reservoir located near the Portsmouth Elementary School on Navy property. If the work goes as currently planned, the construction project should be completed by end of December 2009. At that time, the Navy intends to discontinue regular supply of water from PWFD and plans to convert the existing connection to an emergency connection with PWFD. The water usage is expected to follow the pattern from last year. There were several housing units demolished on the Navy property, however many of those facilities were empty so the consumption is not expected to change significantly.

1-4. Please provide any agreements or contracts between PWFD and the Navy that specify the terms under which PWFD sells water to the Navy?

Response: The connection agreement was the document that specified the sale of water by PWFD to the Navy. A copy of the agreement will be provided as soon as it becomes available.

1-5. In an October 30, 2008 email, the Navy provided Raftelis Financial Consulting with projections of Navy water usage (see attached Exhibit 1). Do these projections include water purchased from PWFD? If so, please provide a breakdown of the amounts purchased from Newport and the amounts purchased from PWFD?

Response: Yes, the following corrected projections include amounts purchased from PWFD. They include the projected increase in military personnel stationed at Newport and improvements to the recovery of condensate from the Navy steam heating system. These projections do not include any additional system flushing requirements related to the injection of chlorimine as a secondary treatment material.
