
The attached Executive Summary provides details of the service.

Verizon Rhode Island Single Line Business PAK for Business Executive Summary

Section 1 - Description

This filing introduces the **Single Line Business PAK for Business**. The Single Line Business PAK is an optional business flat-rated usage package that includes a network access line and a choice of calling services and features at a discounted price. Customers subscribing to the Single Line Business PAK must also subscribe to a business unlimited long distance calling plan from Verizon and Verizon internet service. The Single Line Business PAK is designed to appeal to small to medium business customers who desire a flat, consistent and discounted monthly fee for their communications needs.

The Single Line Business PAK includes the following:

- One (1) Business Exchange Service Line
- Unlimited local calling
- Unlimited intraLATA toll calling
- Choice of any or all of the following: Call Waiting, Three-way Calling, Call Forwarding, Caller ID, and Voice Messaging Service

The Single Line Business PAK is available as one or three-year term commitments. The Single Line Business PAK is available to customers who subscribe to 25 or fewer lines at a location, and customers may have only one Single Line Business PAK per account. The Single Line Business PAK includes a credit associated with the subscription to Verizon Internet Service (Verizon High Speed Internet Service or Verizon FiOS® Internet Service).

Section 2 – Pricing

The rates applicable to the Single Line Business PAK are as follows:

	One-Year Term	Three-Year Term
Single Line Business PAK for Business - monthly	\$61.00	\$59.00
Additional Credit associated with Verizon Internet Service - monthly	\$6.00	\$19.00

Verizon Rhode Island Single Line Business PAK for Business Executive Summary

Customers who subscribe to the three-year term commitment for the Single Line Business PAK will not be charged service and equipment charges associated with connection.

Early termination charges apply for customers who disconnect the service prior to the expiration of their commitment period. The early termination charges are as follows:

One-year Term Commitment - \$75.00

Three-year Term Commitment - \$125 for default within first year, \$100 for default within the second year, and \$75 for default within the third year.

If a customer disconnects service within 60 days from the order completion date, the customer is liable for any monthly charges incurred, but no termination liability applies. Termination charges also do not apply if a customer moves to a new location and retains the service, or if the customer renegotiates a new term commitment of equal or greater value, or upgrades to a different service of equal or greater value.

Verizon certifies that the rates for the Single Line Business PAK for Business are not less than the Long-run Incremental Costs of providing the service.

A.	Single Line Business PAK is an optional business flat-rated usage package with a network access line and calling features and services offered for a one-year or three-year term commitment.
1.	Single Line Business PAK includes the following: <ul style="list-style-type: none"> - One (1) Business Exchange Service Line - Unlimited local calling - Unlimited intraLATA toll calling - Choice of any or all of the following: Call Waiting, Three-Way Calling, Call Forwarding, Caller ID, and Voice Messaging Service.

15.16.2 Regulations	
A.	Single Line Business PAK is available only to customers who subscribe to Verizon Rhode Island as their carrier for local and intraLATA toll calls.
B.	Single Line Business PAK is available to business customers who subscribe to 25 or fewer lines (voice grade or voice grade equivalent) at each location at the time service is initiated.
C.	Customers may only have one Single Line Business PAK per account. A maximum of ten (10) lines can have unlimited calling either with this plan or any other unlimited local and/or toll product offered by Verizon. Customers may not combine this package with the Unlimited Dialtone and CustoPak Packages.
D.	Single Line Business PAK is available with a one-year or three-year term agreement only.
E.	Single Line Business PAK is available only with subscription to a business unlimited nationwide long distance calling plan through Bell Atlantic Communications, Inc. d/b/a/ Verizon Long Distance and Verizon High Speed Internet Service or Verizon FIOS Internet Service.
F.	Single Line Business PAK is not available in combination with other optional calling plans or virtual private network services on a single line.
G.	Customers must be existing Verizon internet subscribers or must order Verizon internet service simultaneously with the order for Single Line Business PAK for Business.

B.	<p>Early termination of a Single Line Business PAK term agreement by the customer will result in a one-time flat Termination Charge of:</p> <p><u>1-year term agreement</u> \$75</p> <p><u>3-year term agreement</u> \$125 for default within the 1st year of the term \$100 for default within the 2nd year of the term \$75 for default within the 3rd year of the term</p>
C.	<p>If the customer discontinues the long distance service component or internet service component associated with the Single Line Business Pak, any remaining components will revert to the individual rate associated with the component.</p> <p>If the customer discontinues the Business Exchange Service Line associated with the Single Line Business Pak, applicable termination charges apply.</p>
D.	If the customer terminates the service within 60 days of the Order Completion Date, the customer is liable for the monthly charges incurred. Termination liability will be waived.
E.	At the end of the term or any subsequent renewal, the agreement will automatically be renewed for a successive one-year or three-year term under the same terms and conditions, unless either party provides advance notice that it does not wish to renew the term. Each subsequent renewal will allow for a 60-day grace period for the subscriber to unsubscribe from the plan without penalty. Pricing will remain the same during any automatic renewal unless the Telephone Company has provided 30 days notice of any change. Customers can move from a one to a three-year term without incurring a penalty.
