Comm. 6-1: Please provide an updated status of the Transmission Cable Purchase Agreement.

Response: Deepwater Wind has received a draft of the referenced agreement National Grid and has commenced its review of the same.

Comm. 6-2: Please provide the process which will be followed to complete the transmission cable from Block Island to the mainland, including timelines.

Response: In order to establish a price for the transmission cable, Deepwater Wind must solicit bids from the suppliers and contractors who will build the system. For the purpose of establishing a preliminary price cap, Deepwater Wind has solicited and is currently awaiting bids from a number of prospective vendors. However, to establish a firm price, Deepwater Wind must provide the bidders with an engineered design of sufficient detail to determine the required quantities of materials and labor and to remove unnecessary contingency. Such designs require detailed data which is not available without field studies. Deepwater Wind has engaged a highly qualified engineering team and is currently undertaking the necessary field studies. Deepwater Wind's engineering team is currently coordinating with National Grid on the design development of the transmission system. A preliminary/indicative timeline for the transmission cable is as follows:
