RESIDENTIAL/COMMERCIAL/INDUSTRIAL SURGE SUPPRESSORS

**Availability**

Customers of the Pascoag Utility District (“Pascoag” or “the District”) have the option of having Electrical Surge Suppressors installed, at no cost, on their property, by Pascoag. Residential and Non-Residential customers, as determined by the District’s rate schedule designations, have the option of paying the actual cost of these Surge Suppressors prior to installation or agree to make twelve equal, interest free, monthly payments to cover this cost. Should a conflict arise between the Commission’s Rules Governing the Purchase and Installation of such Surge Suppressors (the “Rules”) and this provision, the Rules shall supersede.

**Fees**

Customers may, at their discretion, pay the cost of the Surge Suppressor in one payment prior to installation. Customers may also choose to make payments. Under this option customers will be assessed an interest free monthly fee equal to 1/12<sup>th</sup> the cost of the Surge Suppressor.

**Ownership**

After the purchase of the Surge Suppressor, those customers who have either paid in one lump sum or have completed their 12 month payment plan, will own the Surge Suppressor. The Pascoag Utility District retains the right to invoice the customer for the actual cost of removal of the unit, if requested to do so by the customer. In cases where customers close their account with Pascoag before the Surge Suppressor has been completely paid for, the remaining balance will be included in their “Final Bill”.

**Liability**

**The warranty is provided by the manufacturer of the equipment, and is limited to a ten year period from date of installation. Details of the warranty will be provided to the customer upon request. Pascoag Utility District assumes no liability in addition to the manufacturer’s warranty.**

**Installation**

**The Surge Suppressor is installed behind the electric meter and must be installed by Pascoag Utility District.**

**Terms and Conditions**

The District’s Terms and Conditions, as may be amended from time to time, and where not inconsistent with any specific provisions hereof, are a part of this provision.
