I am writing this email to ask the PUC to once again vote NO in the Deepwater Wind/National Grid power purchase agreement. This project makes no sense for the ratepayers RI and their children and grandchildren. The Governor and General Assembly's attempt to circumvent the very process they set up should be proof enough that something is wrong with this proposal.

The problems I have with this project include, but are not limited to the following:

Other less expensive and more reliable sources of renewable energy are available from other sources

A cable to <u>Block Island</u> (which will be built, but isn't included in the price of Deepwater) would solve the problem and cost a fraction of the amount of the Deepwater project.

The State of RI should not be involved with private experimental projects using the ratepayers and future electric rates as capital for a PRIVATE development.

The need for the project is based on the corrupt science of man-made global warming

The Governor's agreement with Deepwater puts into question the results of the RI Ocean SAMP and any other permit reviews conducted by the State. I am not confident that all environment and socioeconomic impacts are being assessed through an objective review. The outcome has been pre-determined.
