#### I. INTRODUCTION

In Docket 4025, the City of Newport, Utilities Department, Water Division ("Newport Water or "Newport") requested an increase for salary and wages. Newport Water estimated the necessary increase because its labor contracts had expired, and it did not know the exact increase it would ultimately negotiate. The Rhode Island Public Utilities Commission ("Commission") granted Newport Water's request for a salary and wages increase, but restricted the increase until Newport negotiated new labor contracts. The Commission continued this restriction in its Docket 4243 Order (No. 20636). Newport has now finalized its labor contracts and calculated the retroactive payments for its union employees. Thus, Newport Water requests permission to unrestrict funds in this account to cover the retroactive increases and also seeks to continue funding the restricted Salary Increase Account at a reduced level. In support of its Petition, Newport relies on the testimony of Julia Forgue, P.E., which is attached hereto and incorporated herein. WHEREFORE, the City of Newport, Utilities Department, Water Division prays that the Rhode Island Public Utilities Commission grant the relief sought herein and all other relief it deems meet and just.

- 3 A. Julia Forgue, P.E. I am employed by the City of Newport where I serve as Director of

- 7 A. I began my employment with the City of Newport on March 12, 2001 as Director of
- 8 Public Works. While Director of Public Works, I also served as the General Manager of

- 10 in December 2007, and I am now the Director of Utilities.

I received a B.S. in Civil Engineering from Northeastern University in 1981 and a M.S. in Civil Engineering from the University of Colorado at Boulder in 1982. I am a registered 3 4 Professional Engineer in Rhode Island and New Hampshire. 5 6 Q. Do you have any professional affiliations? 7 A. Yes, I am a member of the American Water Works Association, New England 8 Waterworks Association and the Rhode Island Waterworks Association. I served as 9 President of the RIWWA from December 2001 to December 2003. I am also a member of the Water Environment Association. 10 11 Q Please describe your role in this proceeding? 12 13 A. To support Newport Water's Miscellaneous Petition For Relief in Docket 4243. 14 Q. Please provide an overview of why Newport is filing the Miscellaneous Petition? 15 A. In Docket 4025, the City of Newport, Utilities Department, Water Division ("Newport 16 Water or "Newport") requested an increase for salary and wages. Newport Water 17 estimated the necessary increase because its labor contracts had expired, and it did not 18 know the exact salary increase it would ultimately negotiate. The Rhode Island Public 19 20 Utilities Commission ("Commission") granted Newport Water's request for a salary and 21 wages increase, but restricted the increase until Newport negotiated new labor 22 contracts. 23 In Docket 4243, the parties reached a Settlement Agreement that continued this 24

25 restricted account. However, the parties agreed to reduce the annual funding from

1	\$91,214 to \$80,931. The Commission approved this Settlement Agreement and ordered
2	Newport to continue funding the restricted Salary Increase Account.
3	
4	At this time, Newport has finalized its labor contracts, we know the amount of the salary
5	and wage increase for FY14 and we can calculate the retroactive payments and
6	prospective salaries for our union employees. Thus, Newport Water seeks to reduce the
7	funding for this account.
8	
9	II. MISCELANEOUS PETITION
10	Q. Can you summarize Newport's new labor contracts?
11	A. Yes. As the Commission knows, Newport Water has labor contracts with two unions –
12	NEA and AFSCME. The new contracts with both unions cover FY 10 thru FY 15 and the
13	applicable terms are as follows:
14	• Both contracts provide for no salary increases for FY 10, 11, or 12.
15	Both contracts require a one-time stipend payment that varies based on
16	individual employees' status and ranges from \$500 to \$2500, net of required
17	withholdings.
18	• Both contracts provide for a 3% COLA retroactive to July 1, 2012 for FY 2013.
19	• Under both contracts, there are no step increases for FY 10, FY 11 or FY 12. Step
20	increases resume starting in FY13.
21	• Both contracts provide for potential pay increases in FY14 and FY15. Union
22	employees will receive the same COLA or pay increase provided to non-union,
23	supervisory employees. If the non-union, supervisory employees do not receive a
24	COLA or pay increase, then the union employees will not either.

1	Q. How much did Newport Water have to pay the Unions retroactively?		
2	A. Newport had to make payments of \$22,075.90 to the NEA employees on October 11,		
3	2012 and \$154,634.86 to AFSCME employees on January 3, 2013. These payments were		
4	made out of Newport Water's operating account, and Newport requests that it be		
5	allowed to unrestrict these amounts to reimburse the operating account.		
6			
7	Q. What was the balance in the restricted salary and wages account after these		
8	payments?		
9	A. Once the amount for the retroactive payouts is released, the account balance will be		
10	\$172,374.01 as of June 30, 2013.		
11			
12	Q. Does Newport propose to continue funding this restricted account, and if so why?		
13	A. Yes. On June 26, 2013, the Newport City Council granted Newport's non-union,		
14	supervisory employees a 1.8% a salary increase for FY14. As such, union employees will		
15	receive an equivalent increase. The total salary and wage payment requirement for FY		
16	13 was \$2,149,014.83. With the 1.8% increase, effective July 1, 2013 for FY14, Newport		
17	Water's salary and wage payments will be \$2,188,830.00. The salary and wage		
18	allowance granted by the Commission in Docket 4243 was \$2,224,547 (which included		
19	two vacancies). Newport proposes to restrict this monthly difference of \$2,976.42		
20	(along with the existing balance) through, at least, the end of FY14.		
21			
22	At the end of FY14, Newport proposes to file a further petition with the Commission. At		
23	that time the balance in the restricted account (approximately \$208,000) can be used in		
24	for various purposes as approved by the Commission:		
25	1. A portion can be used to retroactively cover any step increases earned by		
26	employees in FY14. During FY 2014, certain employees are eligible to receive

1		step increases. By the end of FY14, Newport will know which employees earned
2		step increases and the corresponding amounts. The maximum amount of step
3		increases that Newport will have to pay in FY14 is \$39,515.60.
4	2.	A portion can be used to cover any salary and step increases for FY15. By June
5		30, 2014, Newport should know the amount of increases, if there are any, for
6		FY15 pursuant to the terms of the union contract.
7	3.	A portion can be released to cover other expenses as approved by the
8		Commission.
