Regarding YMax Communication's Tariff Filing dated May 31, 2012 to
implement revisions pursuant to FCC's Order (issued November 18,

Dear Ms. Massaro:

On August 28, 2012, YMax Communications Corp. ("YMax") filed revisions to its Rhode Island No. 2 (Switched Access services) tariff. Earlier today you circulated a copy of this YMax tariff filing to the Docket No. 4344 service list. As indicated in this tariff filing, YMax reverted certain language in this tariff, which was revised in YMax's tariff revision filed on June 1, 2012, back to the language reflected in this tariff prior to that June 1 filing. It was filed to eliminate and thereby render moot the controversial language associated with YMax's June 1 tariff revisions that is specifically at issue in Docket No. 4344. Accordingly, there is no need for further proceedings in this Docket and the Commission should close this Docket. Because YMax has withdrawn the tariff language that is the subject matter of this docket, it would be a waste of Commission resources to keep this proceeding open.

Relatedly, during the August 9, 2012 conference call among parties in this Docket, YMax had agreed to circulate certain information as noted in Ms. Wilson-Frais' August 10, 2012 Procedural Schedule Memorandum in this case; however, given the above, the need for such information is obviated. If the Commission does not, however, close this Docket before the September 5, 2012 conference call that is scheduled in this case, YMax would be prepared to file the requested information if the Commission still considers it necessary.
