

REQUEST TO RELINQUISH ETC DESIGNATION

YMax Communications Corp. (“YMax” or the “Company”), pursuant to Section 54.205 of the Rules of the Federal Communications Commission (“FCC”),¹ and the rules and regulations of the State of Rhode Island and Providence Plantations Public Utilities Commission (the “Commission”), hereby requests to relinquish its Designation as an Eligible Telecommunications Carrier (“ETC”) in Rhode Island. In support of its request, YMax states the following:


1. YMax was designated as an ETC in Rhode Island by Commission Order issued May 1, 2013.
2. YMax has not yet initiated Lifeline service in Rhode Island, and its business plans have been altered such that the provision of Lifeline services is no longer consistent with the Company’s goals at this time.
3. Because YMax does not currently have any Lifeline customers, and there remain a number of alternate ETC providers from which customers can obtain Lifeline service, relinquishment of YMax’s ETC designation will not cause harm to Rhode Island consumers.

4. FCC Rules provide that “A state commission shall permit an eligible telecommunications carrier to relinquish its designation as such a carrier in any area served by more than one eligible telecommunications carrier.”

WHEREFORE, YMax respectfully requests that the Commission issue an Order allowing YMax to relinquish its designation as an ETC.


