<u>MOTION OF THE NARRAGANSETT ELECTRIC COMPANY D/B/A NATIONAL</u> <u>GRID TO ASSERT OBJECTIONS TO LT. GOVERNOR ELECT DANIEL MCKEE'S</u> <u>DATA REQUESTS – SET 2</u>

National Grid¹ objects to Intervenor Lt. Governor Elect Daniel McKee's (McKee) Data Requests - Set 2 (Request) pursuant to Rule 1.18(c) of the Rules of Practice and Procedure for the Rhode Island Public Utilities Commission (PUC). A copy of the Request is attached as <u>Exhibit A</u>.

McKee Data Request 2-1 seeks "final bid prices (cents per kWh) received on [May 14, 2014, August 13, 2014, and November 12, 2014] for the three tranches each consisting of 30% of the commercial load obligations for the January 2015 through June 2015 time period." National Grid objects to this request for the reasons set forth in its response to McKee Data Request 2-1, which the Company filed on December 9, 2014 simultaneously with this Motion. In response to this request, National Grid provided the publicly available Average Winning Price data in lieu of providing the confidential monthly contract prices.

In addition, McKee Data Request 2-2 (a) through (c) seeks the unredacted versions of the Company's Summary of Bids dated May 15, 2014, August 14, 2014, and November 13, 2014, including Attachment 1 of the Company's corresponding Summary of Bids filings with the PUC. McKee Data Request 2-2(d) seeks the unredacted versions of the Results of Competitive Procurement for the Months of January 2015 through December 2016 for the Residential Group, for the Months of January 2015 through December 2015 for the Commercial Group, and for the Months January 2015 through March 2015 for the Industrial Group, dated November 19, 2014, including Attachments 5 and 6 of National Grid's November 19, 2014 Standard Offer Procurement Plan Filing (SOS Filing).

National Grid objects to parts (a) through (c) of the request, which seeks the confidential versions of the Company's Summary of Bids dated May 15, 2014, August 14, 2014, and November 13, 2014, including Attachment 1 of the Company's corresponding Summary of Bids filings. Attachment 1 contains commercially sensitive market information in that it includes all final bids submitted, as well as a historical summary of previous winning bids. Public disclosure of this type of information could affect the balance of the wholesale markets, as well as National Grid's ability to negotiate competitive terms with its wholesale electric suppliers, and is, therefore, confidential and proprietary to those suppliers. This information is also the type of information that the PUC has historically recognized as confidential and proprietary.

In addition, National Grid objects to part (d) of the request, which seeks the confidential versions of Attachments 5 and 6 of the Company's SOS Filing for the reasons set forth above

and in its response to McKee Data Request 2-2, which the Company filed on December 9, 2014 simultaneously with this Motion.² A copy of the Company's Response is attached as <u>Exhibit B</u>.

National Grid respectfully requests that the PUC limit the Request only to the information that is publicly available as provided in response to McKee Data Request 2-1.
