**Summary of Rates**

Dear Ms. Massaro:

On behalf of National Grid<sup>1</sup>, I enclose ten (10) copies of R.I.P.U.C. Tariff No. 2096, Summary of Rates, Standard Offer Service. This tariff sheet reflects the rates approved by the Rhode Island Public Utilities Commission (PUC) at the Open Meeting held on December 23, 2014, in Docket No. 4393 for rates effective January 1, 2015.

R.I.P.U.C. Tariff No. 2096, Summary of Rates, Standard Offer Service, reflects the base Standard Offer Service (SOS) charges approved by the PUC for the Residential, Commercial and Industrial Groups. Specifically, the approved SOS base rate for the Residential Group reflects a 12-month rate consistent with the rate calculated in the Company's response to data request COMM 3-1, part b. For the Commercial Group, the base SOS rate for the fixed price option reflects the PUC decision that the Company defer 10% of the estimated SOS expense expected to be incurred during the period January 2015 through June 2015 and recover that amount during the July 2015 through December 2015 pricing period. The Commercial Group base SOS rate for the fixed price option is calculated in a manner consistent with the calculation included in Attachment COMM 6-9-1, page 2, of the Company's response to data request COMM 6-9. The Commercial Group rates for the variable price option shown on R.I.P.U.C. Tariff No. 2096 reflect a reduction of 10% from the Commercial Group rates for the variable price option originally proposed in the Company's November 19, 2014 SOS filing. The Industrial Group rates reflect the base SOS charges proposed by the Company in its November 19, 2014 filing.
