With this filing, Verizon Rhode Island (“Verizon RI”) proposes to increase the monthly rate of the Regional Essentials and Regional Value packages for residential customers by \$5.00. The monthly rate for Regional Essentials will increase from \$37.04 to \$42.04, and the monthly rate for Regional Value will increase from \$35.04 to \$40.04. Concurrent with the price increase, many of the associated bundle and voice discounts will be increased by \$5.00 to offset the increase in the price of the base monthly rate so that many bundle subscribers will remain at their current rate. Also, customers on a term plan will not be affected by the increase.
