Request:

Re: witness Smith's Direct Testimony page 17 of 30, please provide monthly detail showing:

- a. The movement of individual Dual-Fuel customers from Non-Firm to Firm service;
- b. The movement of individual Dual-Fuel customers from Firm to Non-Firm service;
- c. Each Dual-Fuel customer that left the system for one or more months during the nine months ended March 31, 2013;
- d. Each Dual-Fuel customer added to the system during the nine months ended March 31, 2013 and the actual monthly service volumes and revenue for each added customer for each month of the referenced nine month period;
- e. Provide documentation of any and all adjustments to the Threshold levels of revenue that were made to reflect movements of customers to or from Non-Firm service for:
 - i. The seven months ended January 31, 2013;
 - ii. The two months ended March 31, 2013.

Response:

- a. Please see below for a list of Dual-Fuel customers who were Non-firm customers during Calendar Test Year 2011 and have since migrated from Non-firm to Firm service along with the month of their migration.

Assigned # 3- Moved to Firm service in December 2012.

Assigned # 21- Moved to Firm service in January 2012.

Assigned # 38- Moved to Firm service in November 2012.

Assigned # 45- Moved to Firm service in February 2013.

- b. There were no Dual-Fuel customers moving from Firm to Non-firm service during the nine months ended March 31, 2013.
- c. Customer assigned # 9 was the only dual fuel customer that left the system during the nine months ended March 31, 2013. The customer left the system in July 2012.

Division 2-7, page 2

- d. There were no Dual-Fuel Non-firm customers added to the system during the nine months ended March 31, 2013.
- e. In preparing its response to this request, the Company determined that it should have adjusted both the On-System Margin Threshold of \$1.8 million approved in Docket No. 4323 in effect for the period February 2013 and March 2013 and the On-System Margin Threshold of \$2.816 million originally approved in Docket 3943 and modified in Docket No. 4333 in effect for the period July 2012 through January 2013. These adjustments, which the Company is making in this response, however, offset one another and therefore result in a modest increase in the Total Margin in excess of Threshold of \$5,707 (a credit due to customers of \$462,061 filed in Schedule MCS-6 as compared to the revised credit due to customers of \$467,768 shown in Attachment DIV-2-7-e, Line 10, Column (p)). These small adjustments have had no impact to the propose On-System Margin Credit Factor proposed by the Company of (\$0.0012) per therm effective November 1, 2013.

In accordance with the Settlement Agreement in Docket No. 4323, the Company must adjust the \$1.8 million Threshold level to reflect the movement of customers between Firm and Non-firm service. The Company determined that four customers who were Non-firm customers during the 2011 Calendar Test Year in Docket No. 4323 have since migrated to Firm service. In accordance with the Settlement Agreement, the Company must reduce the On-System Margin Threshold by the Non-firm customers' forecasted rate year usage multiplied by the applicable Non-firm rate. In Attachment DIV-2-7-e, page 1, lines 1-7, the Company has calculated the annual Non-firm margin for these four customers to be \$154,849 and therefore is reducing the On-System Margin Threshold to \$1,645,151 as shown in DIV - 2-7-e, page 1, Column (h), line 8.

In accordance with the Docket No. 3943 and modified in Docket No. 4333, the Company must adjust the \$2.816 million Threshold level to retain a portion of any and all incremental natural gas distribution margin received by converting a Non-firm customer to Firm service. In accordance with the Company's tariff that was in effect from July 2012 through January 2013, the Company is to increase the On-System Margin Threshold by the minimum take commitment. During the period July 2012 through January 2013, two customers had a Minimum Margin Agreement with the Company for \$53,756 per year beginning in September 2012 and January 2013. In Attachment DIV-2-7-e, the Company has increased the On-System Margin Threshold by 5/12th of the annual minimum take commitment of \$46,865, and 1/12th of the annual minimum take commitment of \$6,891 or \$20,101 as shown in line 9 of the attachment mentioned above.

Overall, these two adjustments result in a small increase of \$5,707 to the total On-System Margin credit. As indicated above, the Company's revision does not impact the overall factor proposed in the Company's DAC filing.

In addition to these adjustments to the On-System Margin Thresholds, the Company also discovered that the billing for a Firm dual fuel customer Assigned # 57 has been understated for the period July 2012 through January 2013. The Company is in the process of cancelling and rebilling this customer and will update this response in early October when the billing correction has been processed in the Company's billing system and the impact on the On-System Margin credit can be determined.

Dear Chris,

National Grid has had extensive discussions with the Rhode Island Division of Public Utilities and Carriers to modify the document titled "Stipulation Regarding Reconciliation of Revenues from Firm and Non-Firm Dual Fuel Customers." Collectively, National Grid customers who are part of this stipulation are referred to as "Dual Fuel Customers." This modification would enable National Grid to retain a portion of any and all incremental natural gas distribution margin received by virtue of a non-firm customer switching to firm service. This modification would also enable National Grid to utilize this incremental gas distribution margin to reduce the "Contribution in Aid of Construction" associated with any gas infrastructure work that National Grid installed, or has to install, to provide firm gas service to a former non-firm gas customer and to ensure the reliability of its gas distribution system.

In the case of the Brown University Central Boiler Plant, National Grid collected a Contribution in Aid of Construction of \$379,715 in 2010 which reimbursed National Grid for gas infrastructure that was installed upstream of the Brown University Central Boiler Plant to reinforce our gas distribution system and to ensure the reliability of firm gas service to the Brown Central Boiler Plant

As part of this modification, National Grid must receive a written commitment from a Dual Fuel customer for a minimum amount of firm gas usage for a period of not less than five years. Therefore, to comply with the terms of this modification, Brown University and National Grid will collectively agree to the following terms:

Obligation of Brown University

Brown University agrees to utilize firm natural gas at the Central Boiler Plant for the next five years. In order to meet the requirements of this agreement, Brown University agrees to provide National Grid with a minimum incremental margin amount of **\$46,865** each year, for the period September 1, 2012 thru August 30, 2017. If this minimum margin is not met, National Grid will invoice Brown University for the additional monies needed to meet the minimum margin amount.

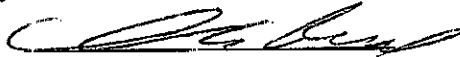
National Grid recognizes that, for reliability purposes, the Brown University Central Boiler Plant has dual fuel capability. National Grid also understands that in order to be in compliance with state regulation, these boilers must be tested on fuel oil from time to time. Nothing in this agreement shall preclude Brown University from testing the boilers on fuel oil.

Obligation of National Grid

National Grid will return to Brown University the earlier collected Contribution in Aid of Construction of \$379,715 minus the minimum regulatory contribution of \$600. Therefore, the net amount to be returned to Brown University will be \$379,115.

If you are in agreement with this Minimum Margin Agreement, please execute below and return an executed copy back to National Grid. In return, National Grid will provide a fully executed agreement back to Brown University for your records.

Dear Telmo,

On July 11, 2012, the Rhode Island Public Utilities Commission modified the On-System Margin Credits Provisions of the Company's Distribution Adjustment Charge tariff, RIPUC NG-Gas No. 101, Section 3, Schedule A, subpart 3.8. Those provisions relate to Dual Fuel customers, which are an identified group of customers whose facilities have the ability to alternate between natural gas and oil to fuel their operations. This modification provides that the tariff threshold level for determining positive or negative On-System credits may be adjusted to reflect incremental natural gas distribution revenue margin received by virtue of a non-firm customer's making new investments resulting in incremental distribution revenue for the period ending June 30 of each year derived through applicable minimum take commitments. National Grid may utilize a portion of this incremental gas distribution margin to reduce the "Contribution in Aid of Construction" associated with any gas infrastructure work that National Grid installs, or has to install, to provide firm gas service to a Dual Fuel gas customer and to ensure the reliability of its gas distribution system.

In the case of Key Container, National Grid will need to collect a Contribution in Aid of Construction of \$600 (Minimum Charge), for the installation of 43' of 6" plastic low pressure service pipe to a location at 21 Campbell St, Pawtucket.

As part of the On-System Margin Credits Provisions tariff modification, National Grid must receive a written commitment from a Dual Fuel customer for a minimum amount of firm gas usage for a period not to exceed five years. Therefore, to comply with the terms of this modification, Key Container and National Grid will collectively agree to the following terms:

Obligation of Key Container

Key Container agrees to utilize firm natural gas for the next five years. In order to meet the requirements of this agreement, Key Container agrees to provide National Grid with a minimum distribution margin amount of **\$6,891** each year, for a five year period. The five year period will commence when the boiler is converted to gas which is expected to be January 1, 2013 and expire on December 31, 2017. If this minimum margin is not met, National Grid will invoice Key container for the additional monies needed to meet the minimum margin amount.

Obligation of National Grid

National Grid will install 43 feet of 6" Plastic low pressure service to the agreed upon location.

If you are in agreement with this Minimum Take Agreement, please execute below and return an executed copy back to National Grid. In return, National Grid will provide a fully executed agreement back to Key Container for your records.

Response:

- a. The Narragansett Electric Company (TNEC) retained Hinckley Allen to obtain access to several properties so that the remediation of the 170 Allens Avenue site could proceed under the Rhode Island Department of Environmental Management's (RIDEM's) remedial approval.

For Lot 325, which is part of the remediation "site" and owned by Ms. Gail Conley, Hinckley Allen provided notice to Ms. Conley's attorney, Dr. Patrick Conley, under the 2006 Access Agreement governing work on Lot 325 so that work could proceed. There were no other legal issues involved with access to Lot 325 other than providing such notice.

Division 2-18, page 2

Access to Lot 361, which is owned by Sims Metal Management (SMM) and is not part of the remediation site, was also necessary to perform the RIDEM approved remedial work. Hinckley Allen engaged in protracted negotiations with SMM during the subject period in order to obtain such access. After months of negotiations, an access agreement between TNEC and SMM was executed in July of 2013.

Access to Public Street was also required to perform the remediation. An easement was required as part of the access. The preparation of the easement was partially performed during the subject period. For the easement in Public Street, Hinckley Allen presented a petition to the City of Providence to obtain the easement so that remediation work could be done within Public Street and manholes added to the drainage system within the street. As part of this process, Hinckley Allen presented the need for and requirements of the easement, as well as the remediation plan, on two separate occasions to the Providence Public Works Committee and then appeared at City Council meetings where the easement was addressed. The Public Works Committee made a positive recommendation to the City Council for approval of the easement, and the City Council unanimously approved the easement in July 2013. During the process, Hinckley Allen worked with and facilitated an amended appraisal of the easement, which includes temporary and permanent aspects, that resulted in a much lower easement cost to TNEC.

Any associated condensate and drip water are removed from the field and disposed of by a licensed Hazardous Waste Transporter. The costs included in this project relate to the PCB testing, decontamination and transport of these materials. Please see Attachment DIV 2-20b for details on the dates, activity and location associated with the charges for this project.
- b. The detail of the costs associated with the Construction/Disposal/Removal activity incurred during the nine months ended 03/31/2013 are shown in Attachment DIV 2-20b.
- c. The costs for the PCB Regulated Pipe Abandonment project for the twelve-month periods ending June 30, 2012 and June 30, 2011 were \$122,057 and \$113,045, respectively. The costs for the PCB Regulated Pipe Abandonment project for the nine-month period ending March 31, 2013 were \$82,656 (which scaled to twelve months is \$110,208). - b. an estimate of costs expected to be incurred prospectively to rectify problems related to implementation of the new financial system
- c. a description of how the Company is accounting for the costs identified in parts a and b.

Response:

Background

By way of background and context, since the KeySpan merger in 2007, National Grid had been operating two financial accounting systems (Oracle and PeopleSoft). In late September 2012, National Grid began implementing a business change program, which included a system conversion to consolidate these two systems onto a single Enterprise Resource Planning ("ERP") platform and create a single set of processes to support the US business ("SAP" or the "US Foundation Program"). The primary objective of the US Foundation Program was the integration of National Grid's Human Resources ("HR"), Supply Chain, and Finance (Back Office/ERP) information technology platforms and business processes.

National Grid launched the majority of SAP applications on November 5, 2012. As discussed in the Company's April 10, 2013 response to the Division's letter dated March 11, 2013, a copy of which was provided to the Commission, the Company experienced significant implementation difficulties. Despite progress, the Company has continued to face implementation difficulties since the letter of April 10 was filed.

Costs Incurred to Date and Accounting

The costs incurred to date are set forth below, along with associated accounting. These costs are all-inclusive, and not limited to costs that relate solely to fixing design flaws. They include initial capital costs associated with system design, training, costs incurred in performing transactional work to correct data entry issues, employee support costs, process improvements, improving controls,

costs of fixing root causes, and costs incurred to implement processes outside of the system to process payroll and prepare financial reports, among other related stabilization costs.

O&M costs associated with stabilization activities will be borne by shareholders and, thus, not recovered from customers. Whether the Company would seek recovery of any capitalized costs above the amounts currently reflected in rates will be determined after project completion and an appropriate accounting evaluation, taking into account prevailing ratemaking rules.

Inception to November 5, 2012

National Grid spent approximately \$360 million to design, build, test and launch the US Foundation Program. Those costs were incurred from inception to approximately November 5, 2012 when the system was largely launched. Those costs were accounted for as follows:

\$128.0 million	\$231.6 million was capitalized at National Grid USA Service Company, Inc. ("Service Company")

None of the operation and maintenance ("O&M") costs were included in Narragansett Electric ("Narragansett") rates charged to electric and gas customers. The amount of SAP costs that was assumed would be capitalized in Narragansett's last rate case in Docket No. 4323 was \$273.4 million. Although this amount is higher than the \$231.6 million actually capitalized as of the system implementation date, the Company has incurred additional amounts of capitalized costs as described below. Because the SAP system has been capitalized by the Service Company, Narragansett is charged a rental fee by the Service Company for an allocated share of the associated revenue requirement of the system. Narragansett's share of the annual revenue requirement of the assumed capitalized amount of \$273.4 million is \$2.6 million and \$1.1 million for electric and gas, respectively, as approved in Docket No. 4323.

November 2012 through March 31, 2013

From November 2012 through March 31, 2013, National Grid incurred additional costs of approximately \$132.8 million. Those costs were accounted for as follows:

Operation and Maintenance Expense	Capital Expenditures
\$90.4 million was charged to the parent company, National Grid USA	\$42.4 million was capitalized at the Service Company

Through March 31, 2013, \$274.0 million of costs were capitalized by the Service Company.

April 1, 2013 through July 2013

From April 1, 2013 through July 2013, National Grid has incurred approximately \$138.8 million all of which has been expensed.

Forecasting Future Expenditures

As evidenced by the cost incurrence to date, the difficulties encountered with resolving the US Foundation Program issues have been more than could have reasonably been contemplated. The Company has performed a review of the tasks it believes are needed to bring the system to an acceptable level of performance, but at this point the Company is not forecasting what the final total of stabilization costs is likely to be. As of today, National Grid is forecasting total expenditures for this fiscal year in the range of \$283 million to \$333 million (which range includes the \$138.8 million spent through July). However, the Company is developing a program of work for fiscal year 2014 at the lower end of the range. The Company expects stabilization efforts to continue into the next fiscal

year. Throughout the remainder of this fiscal year, the Company will be reviewing the status of the stabilization efforts to determine what level of additional expenditure will be necessary.

Accounting for Forecasted Expenditures

National Grid anticipates that future O&M system stabilization expenses will be allocated and charged to the operating companies to a below-the-line account, subject to review at the end of the fiscal year. Any capitalized amounts will be recorded at the Service Company.
