Comm. 1-1: Please provide the name, address and contact person for all entities, corporate or otherwise, responsible for financing, in whole or part, the Bowers Wind Project.

Response: All development financing for the Bowers Wind Project has been handled by First Wind Holdings, LLC ("First Wind"), the ultimate indirect parent of Champlain Wind, LLC. First Wind will also be responsible for securing Champlain Wind, LLC's financing for the Bowers Wind Project. The final construction financing structure will be determined closer to actual construction and will be based on market conditions at that time. To date, First Wind has successfully financed five grid-scale projects in Maine utilizing a combination of First Wind equity and third-party debt financing to fund construction. First Wind expects that the majority of the Bowers Wind Project's construction financing will also be provided by third-party debt and/or tax equity with a smaller portion (typically in the range of 20% to 30%) funded with First Wind equity. Response: In accordance with First Wind's Northeast Joint Venture with Emera Inc. which closed on June 15, 2012, Northeast Wind Partners II, LLC is owned 51% by First Wind Holdings, LLC and 49% by Emera, Inc. Through the Joint Venture transaction, Emera acquired a 49% equity interest in First Wind's 385 MW portfolio of operating wind energy projects in the Northeast. First Wind will exclusively manage the development of new projects, including the Bowers Wind Project, and transfer them to the Joint Venture once a set of prescribed investment criteria is met.

The Joint Venture with Emera provides First Wind with a dependable and attractively priced source of equity capital to continue development activities, gives First Wind access to Emera's commercial capabilities in the Northeast, and strengthens our ability to build and operate new wind energy projects.

First Wind anticipates it will transfer the Bowers project into the Joint Venture once it satisfies the prescribed transfer criteria, which typically occurs at, or around, closing of construction financing
