On behalf of National Grid,<sup>1</sup> enclosed please find the Company's Lighting Inventory Report providing the distribution of lighting inventory by wattage range with actual output information in compliance with the Rhode Island Public Utilities Commission's Report and Order No. 21704, at page 48, Paragraph 6, in the above-referenced docket.

As of the annual inventory date of December 31, 2019, 23 customers received service on the Street and Area Lighting – Customer Owned Equipment S-05 Tariff, RIPUC No. 2190.
