With this filing, Verizon Rhode Island (“Verizon RI”) proposes to modify the terms of the existing Regional Essentials FiOS Bundle Discount I. The filing also modifies the monthly discount for new subscribers to the Regional Essentials FiOS Bundle Discount II.

The Regional Essentials Bundle Discounts provide discounts to the Regional Essentials subscriber when the subscriber also purchases additional services such as long distance calling plans and FiOS products (Internet and/or TV). This filing introduces a provision that enables Regional Essentials FiOS Bundle Discount I subscribers to upgrade their FiOS Internet and/or FiOS TV selection and retain the discount. This filing also modifies the level of the discount provided to new subscribers to the Regional Essentials FiOS Bundle Discount II. Current subscribers to the Regional Essentials FiOS Bundle Discount II are unaffected by the change.

3.	Discontinuance of any one of the services listed above will result in immediate termination of the discount. Customers are limited to one discount only and cannot combine discounts. Each product must be billed by Verizon RI.

1.	Conclusion of the FiOS Bundle Discount I - 6-month Commitment – At the expiration of the initial 6-month term, the FiOS Bundle Discount I will continue at the 6-month initial term commitment FiOS Bundle Discount I rates specified in Part M of this tariff.

Conclusion of the FiOS Bundle Discount I - 12-month Commitment – For subscribers on or before September 21, 2007, the FiOS Bundle Discount I will renew continuously at the renewal rates specified in Part M of this Tariff. For subscribers on or after September 22, 2007, the FiOS Bundle Discount I will continue at the 12-month Commitment FiOS Bundle Discount I rates specified in Part M of this Tariff.
