Request:

Please provide details of all disbursements of incentives by National Grid for Toray CHP project.

- a. Total amount expected to be disbursed to Toray;
- b. The date, amount and specific source of any incentive disbursement to Toray to date; and
- c. The amount of any incentive disbursements outstanding, and expected to be paid to Toray.

Response:

- a. The total incentive package of \$15,890,000, as approved by the Rhode Island Public Utilities Commission, consists of the following payments:
 - \$13,500,000 installation incentive from National Grid's Energy Efficiency programs;
 - \$1,800,000 rebate from National Grid's Natural Gas Advanced Gas Technologies ("AGT") program; and
 - \$590,000 as a performance-based incentive from National Grid's Energy Efficiency programs
- b. To date, \$10,800,000 (80%) of the installation incentive has been disbursed. This incentive payment was disbursed on October 4, 2014. The source of the disbursement is the 2014 Energy Efficiency Program funds, specifically for C&I Retrofit customer incentives.
- c. The remaining \$2,700,000 (20%) of the installation incentive will be paid when commissioning is completed and milestones 3 & 4 of the MRD have been met (please see the Company's response to Post-Hearing Data Request COMM 1-1). The AGT incentive payments will begin after commissioning is completed and will be disbursed in 4 payments over 4 years. The \$590,000 performance based incentive will be paid out as \$20/kW per year starting six months after final commissioning.
