Pursuant to the instruction set forth in the Arbitrator's Decision (the Decision) in this matter, which was filed on April 2, 2015, National Grid¹ hereby provides notice to the Rhode Island Public Utilities Commission regarding the recommendations in the Decision it will accept and those which it will not. *See* Arbitrator's Decision at 40-41.

National Grid will accept all the findings in Part VII and the conclusions in Part VIII of the Arbitrator's Decision. *See* Arbitrator's Decision at 24-40. With respect to the Recommendations in Part VIII.A of the Arbitrator's Decision, National Grid understands these to be ideas for future consideration, and not proposed orders for current action. *See* Arbitrator's Decision at 41. Additionally, National Grid views those Recommendations as the proper subject matter for a docket considering revisions to The Narragansett Electric Company d/b/a National Grid's Standards for Connecting Distributed Generation, RIPUC No. 2078. As such, National Grid is willing to consider these recommendations if proposed in a different docket, but is not willing to adopt them at this time.
