Request:

For the month of January 2015, with regard to Standard Offer Service, please provide the following information:

- a. The total kWh consumed, by rate class, for SOS
- b. The amount of kWh, by rate class, for January 2015 that National Grid supplied with spot market purchases
- c. The average price, by rate class, of those spot market purchases
- d. The assumed spot market price that National Grid used for January 2015 when it set SOS prices in November and December 2014 for the January through June 2015 period.

Response:

a. The Company is providing the initial (37 hour) settlement loads provided to the ISO-NE by procurement group, as seen in the table below.

b. The Company procures 10% of its Residential and Commercial Groups' SOS requirements in the spot market. It does not procure any of the Industrial SOS requirements in the spot market.
