ORDER

I. Introduction

National Grid currently procures Standard Offer Service (SOS) Service supply on behalf of its customers pursuant to the 2016 SOS Procurement Plan approved by the Public Utilities

Commission on July 1, 2015. Pursuant to the 2016 SOS Procurement Plan, National Grid conducts

solicitations throughout the year for Standard Offer Service in varying contract lengths. As a result

of these solicitations, the Company files Residential and Commercial SOS rates twice per year and

Industrial SOS rates on a quarterly basis. The within rate filings are made pursuant to the

Company's approved 2016 SOS Procurement Plan.

II. National Grid's Proposed Standard Offer Service Rates for the Industrial Group for

the period July 2016 through September 2016

On April 13, 2016, National Grid proposed the following SOS rates for the Industrial Group

for the period July 2016 through September 2016:1

July 2016: August 2016: \$0.05035/kWh \$0.04731/kWh

September 2016: \$0.04751/kWh

The three month average of the proposed industrial rates, including SOS Adjustment

Factor, SOS Administrative Cost Factor, and the Renewable Energy Standard (RES) Charge, is

\$0.04589/kWh which is a 3% decrease from the three month average rate of \$0.04720/kWh for the period April 2016 through June 2016.² The proposed three-month average industrial rate of \$0.04589/kWh for the period July through September 2016 is a 29% decrease from the three-month average industrial rate of \$0.06448/kWh for the same three-month period in 2015.³

III. Decision

On May 18, 2016, the Division of Public Utilities and Carriers (Division) filed a memorandum finding that the proposed SOS industrial rates for the period July 2016 through September 2016 are in compliance with the 2016 SOS Procurement Plan approved by the PUC on July 1, 2015. On May 20, 2016, based on the recommendation of the Division, the PUC voted unanimously to approve the Company's proposed SOS rates for the Industrial Group for the period July 2016 through September 2016.
