OFFICE OF ENERGY RESOURCES' REQUEST FOR FUNDING TO PERFORM A QUALITY ASSURANCE STUDY OF THE RENEWABLE ENERGY GROWTH PROGRAM

I. SUMMARY OF REQUEST

Title of Requested Study/Report:	2017-2018 Study of Renewable Energy Installation Quality in the Renewable Energy Growth Program ("RE Growth Program")
Purpose of the Study/Report:	To independently evaluate the quality of installations of projects installed through the RE Growth Program.
Authority	R.I. Gen. Laws § 39-26.6-4(b)

II. STATUTORY AUTHORITY

This request is made pursuant to R.I. Gen. Laws § 39-26.6-4(b) which provides that "[t]he office [OER], in consultation with the board [DG Board], shall be authorized to hire, or to request the electric-distribution company to hire, the services of qualified consultants to perform ceiling price studies subject to commission [Public Utilities Commission] approval that shall be granted or denied within sixty (60) days of receipt of such request from the office. The cost of such studies shall be recoverable through the rate-reconciliation provisions of the electric-distribution company set forth in § 39-26.6-25, subject to commission approval. In addition, the office, in consultation with the board, may request the commission to approve other costs incurred by the board, office,

or the electric-distribution company to utilize consultants for annual programmatic services or to perform any other studies and reports, subject to the review and approval of the commission, that shall be granted or denied within one hundred twenty (120) days of receipt of such request from the office, and that shall be recoverable through the same reconciliation provisions".

III. ADDITIONAL INFORMATION

On June 26, 2017, the DG Board voted unanimously to authorize and direct OER to request funding in the amount of \$145,000.00 to cover the anticipated costs of a 2017-2018 Study of Renewable Energy Installation Quality in the Renewable Energy Growth Program ("Study"). The Study will examine the quality of renewable energy installations funded by the RE Growth Program. The scope of work will include performing inspections, conducting a formal customer survey, drafting and issuing a report, and making a presentation.

The Study is a follow-up to the 2015-2016 study which was conducted by Cadmus Group, Inc. ("Cadmus") at a cost of \$125,000.00. The increase in cost for this year's Study is attributable to an expected increase in medium solar inspections and large solar inspections and the addition of a formal customer survey. The customer survey process will include developing survey content, coordinating with National Grid, issuing the survey, compiling responses, analyzing feedback, and providing a report detailing the survey results.

Inspections will begin in the fall and continue throughout the winter. The anticipated breakdown of project types to be inspected is as follows:

Project Type	Number of Inspections
Small Scale Solar	85
Medium Scale Solar	10
Large Commercial Scale Solar	5
Wind Projects	1

Projects from the 2015, 2016 and 2017 RE Growth Program years may be inspected as part

of this Study. Projects from prior RE Growth Program years may be examined because medium,

large and commercial projects that received a certificate of eligibility from National Grid during

the 2015 and 2016 RE Growth Programs years are being installed during the 2017 and 2018

calendar years.

Projects to be inspected will be selected and priced by size as opposed to other variables

such as location and mounting type. If the Public Utilities Commission ("PUC") or DG Board has

a specific interest in location or other project variable, Cadmus is amendable to adjusting its

inspection list.

The Study will result in a final report which will be ready shortly after conclusion of the

2017 RE Growth Program year which ends March 31, 2018. Last year's report was finalized on

April 20th and a similar timeline for this Study is anticipated. A public presentation to the PUC

and DG Board is included within the proposed budget.

IV. CONCLUSION

WHEREFORE, pursuant to R.I. Gen. Laws § 39-26.6-4(b), OER respectfully requests that

the PUC grant this request.
