The proposed retention of the stop signs gives an additional level of protection/safety. Although it somewhat differs from the recommended layout in the MUTCD, it certainly does not detract anything from the design and could be considered an enhancement. It seems reasonable for them to want everyone to stop.

Their other modifications conform with our previous recommendations.
