

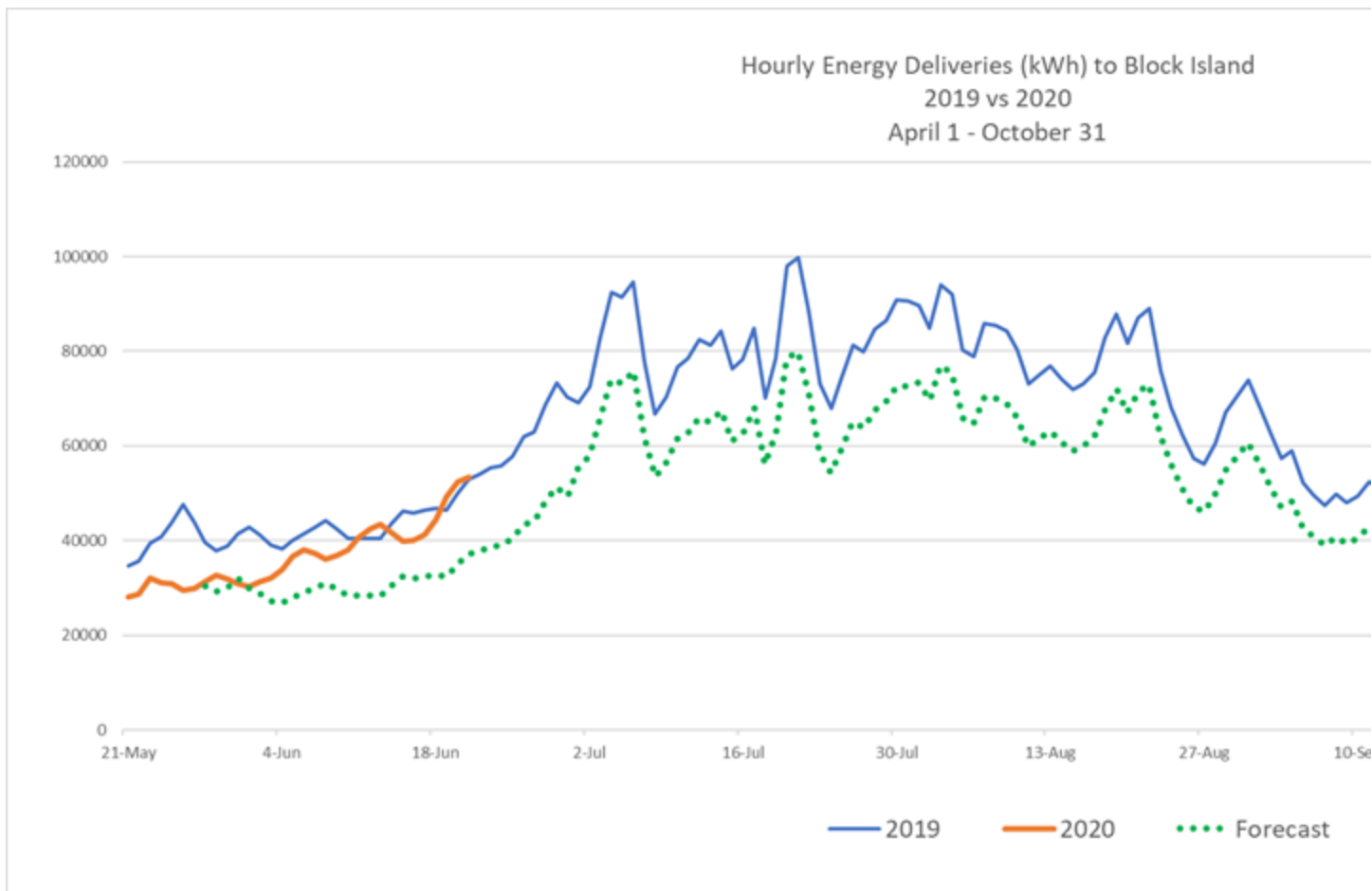

Hi Cindy, we estimated a 30% reduction in June and we are currently down 8%. In the last two weeks most of the businesses have opened and there has been a noticeable uptick in day trip tourists the past two weekends. There are also some businesses that have not The TNS Town Council is meeting this week and I've heard discussions of a renewed mandatory facemask ordinance which would certainly have an impact on visitors. This combined with the fact that the town has cancelled all 4<sup>th</sup> of July festivities adds to a lot of uncertainty.
