## **NOTICE OF PUBLIC HEARING**

Pursuant to the provisions of R.I. Gen. Laws §39-3-11, as amended, the Public Utilities Commission (PUC) will conduct a hearing on <u>Wednesday</u>, <u>March 29</u>, <u>2017</u> @ <u>9:30 A.M.</u> in Hearing Room A at the PUC's office located 89 Jefferson Boulevard, Warwick, Rhode Island.

In this docket, the PUC will examine National Grid's proposal to implement rate changes contained in the Company's 2017 Retail Rate Filing and 2017 Renewable Energy Standard Charge Filing for effect April 1, 2017. The Company proposes rate changes that arise out of the annual reconciliation of the Company's Standard Offer Service (SOS), the SOS Administrative Adjustment Provision, transmission expenses pursuant to the Transmission Service Cost Adjustment Provision, and the calculation of its transition charge pursuant to its Non-Bypassable Transition Charge Adjustment Provision. These tariff provisions provide for the reconciliation and recovery of actual revenues and expenses incurred by the Company for the period January 2016 through December 2016 and estimated revenues and expenses projected to be incurred from April 1, 2017 through March 31, 2018. Additionally, the Company proposes rate adjustments arising out of the reconciliation of the Net Metering Provision, the Long-Term Contracting for Renewable Energy Recovery Provision, and the calculation of the Renewable Energy Standard Charge.

The combined net effect of the proposed rate changes on a typical residential Standard Offer Service customer using 500 kWh per month is an increase of \$0.25 from \$94.48 to \$94.73 or approximately 0.3%. The PUC may approve different rates that may be higher or lower than those proposed by National Grid. The PUC may rule immediately at the conclusion of the hearing.
