National Grid¹ is filing this report with the Rhode Island Public Utilities Commission (PUC) in compliance with the PUC's Open Meeting decision on September 6, 2018 in Docket No. 4763, which required the Company to file an annual report with the PUC that contains the following information: (1) the weekly average of Pre-Application Reports for the prior calendar year; (2) the weekly minimum and maximum number of Pre-Application Reports for the prior calendar year; and (3) the number of delays that were issued due to exceeding a reasonable number of applications under review during the prior calendar year. Capitalized terms not defined herein shall have the meaning ascribed to such terms in the Standards for Connecting Distributed Generation, RIPUC No. 2180 (DG Tariff).

Pursuant to the PUC's decision in the above-referenced docket, National Grid is providing the following information regarding Pre-Application Reports under Section 3.2 of the DG Tariff.

1. The weekly average of Pre-Application Reports for the prior calendar year;
2. The weekly minimum and maximum number of Pre-Application Reports for the prior calendar year; and
3. The number of delays that were issued due to exceeding a reasonable number of applications under review during the prior calendar year.

This is the second Annual Report to be filed under Section 3.2 of the DG Tariff since the PUC's approval of the Company's tariff advice on September 6, 2018 in Docket No. 4763. This Annual Report covers the time spanning January 1, 2019 through December 31, 2019 of the calendar years in order to align the report with the annual filing of the Company's Performance Incentive Mechanism Annual Report in Docket No. 4770.
