Response:

Please refer to Attachment DIV 36-1 for the requested information. The rate year and data year expenses have decreased because of the updates in the Tax Cuts and Jobs Act of 2017 (the Act). The Act affected the Gas Business Enablement revenue requirement in three ways, as described below:

1. Decrease to pre-tax weighted average cost of capital (WACC) – The decrease in the federal income tax rate from 35 percent to 21 percent reduced the amount of income tax to be recovered on the return on equity component of the revenue requirement.
2. Decrease to federal income tax rate in calculation of deferred income taxes - The decrease in the federal income tax rate from 35 percent to 21 percent reduced the National Grid USA Service Company, Inc. (Service Company) total effective income tax rate from 40.2 percent to 27.32 percent in its calculation of deferred income taxes in rate base.
3. Change to Bonus Depreciation – Prior to the passing of the Act, the Company calculated bonus depreciation at a rate of 50 percent, 40 percent or 30 percent for Service Company assets depending on the year placed into service. With the passing of the Act, the Company is now calculating bonus depreciation at 100 percent for all qualified Service Company work streams with a recovery period of less than 20 years that are acquired and placed into service after September 27, 2017 and through December 31, 2022.
