Response:

None of the settlements listed in the Company's response to PUC 1-65 are currently being charged to customers. All claims listed in Attachment PUC 1-65 relate to general liability or auto claims. Recovery of general liability and auto claims in the Company's revenue requirement is generally limited to a historical average of actual claims paid. The claims included in Attachment PUC 1-65 were all paid in 2015 and 2016, and therefore would not have been included in the Company's allowance for uninsured claims in current base distribution rates (RIPUC Docket No. 4323). Current rates include the average of actual claims paid in calendar years 2007 through 2011.

Please note, however, that the proposed allowance for uninsured claims included in the revenue requirement in this docket is based on the five-year average of actual claims paid during the 12-month periods ended June 30, 2013; June 30, 2014; June 30, 2015; June 30, 2016; and June 30, 2017. Therefore, all the claims listed in Attachment PUC 1-65 were included in the calculation of the allowance for uninsured claims of \$1,858,628 for Narragansett Electric and \$644,861 for Narragansett Gas as shown in Schedule MAL-19 at Pages 6 and 7, respectively.

For ease of reference, the Company's response to PUC 1-65 has been included with this response as Attachment NERI 11-1.
