Dear Ms. Hogan,

I write again with regards to the above-entitled docket. The Division's Comments are due to be filed on July 26, 2019. This deadline assumed receipt of the plans by July 12, 2019. Due to the complexity and time associated with preparing the stamped design and construction set of plans, the plans were only just received for review by the Division's consultant, Pare Corp. ("Pare") on July 23, 2019. Additional time is required to enable Pare to review those plans, for Pare to prepare a report to the Division, and for the Division to review the report and file its comments with the Commission. The Division, therefore, requests the Procedural Schedule be amended as follows:
