MOTION TO INTERVENE


NOW COMES the City of East Providence (“COEP”), and pursuant to Rule 1.14 of the Rules of Practice and Procedure for the Rhode Island Public Utilities Commission (“Commission”), moves that the Commission grant the COEP’s right to intervene as a party in the above-captioned Docket for the reasons set forth herein:

1. The COEP owns and operates its own water distribution system which serves all residents, businesses, and other entities within the City.
2. The COEP purchases 100% of its water supply from the Providence Water Supply Board.
4. The increase sought by the Providence Water Supply Board represents a substantial increase in the wholesale price of water the COEP purchases from Providence.
5. Any increase in Providence’s wholesale water rate will result in increased water rates for the COEP’s customers.
6. The COEP has a significant interest that will be directly affected by the Commission’s review and decision in this matter.
7. This interest is not adequately represented or protected by the existing parties in this Docket.
8. In addition, the COEP’s participation in this Docket is in the public interest.

WHEREFORE, the City of East Providence requests that the Commission grant its Motion to Intervene and that it be granted status as a party in this proceeding, and that the Commission grant all other relief it deems meet and just.


