Request:

In response to PUC 1-6, National Grid notes that “in the course of updating this table, the Company identified that the values in column (a), ‘excess generation credit/SOS rate’, included the Renewable Energy Standard (RES) Charge. Renewable Generation Credits do not include the RES charge. Therefore, this charge has been removed from column (a) for all customer rate classes where it was [previously] included.” Please confirm whether National Grid historically included the RES charge in Renewable Generation Credits paid to net metering customers.

Request:

No, the Company has never included the RES charge in Renewable Generation Credits paid to net metering customers. The Company incorrectly included the charge in table shown in Attachment PUC 2-8 in Docket 4930. This table was corrected in the updated Attachment PUC 1-6 in Docket 5005.
